# President's Message

### **Annual Meeting**

The annual meeting was held on January 19th at the Jenn Park pavilion and was well attended. We got to discuss what's going on in our neighborhood, and enjoy some tasty hot food.

The board would like to welcome new board members Rob Connors, Paul Odenwelder and Phil Marble. The board would like to thank retiring members Ron Gillum, RJ Russell and Chad Worland for their service to the Indian Lake community.

### Lawrence Sewer Project Update

The City is moving forward with its plan to install two lift stations within and a third adjacent to our neighborhood. They are also planning to install individual grinder pumps at each property that needs one. This mainly affects residents on Winona and on South Drive.

The Association received a letter in December regarding easements for lift stations on common property. We were offered \$800 for the use of our land and told where the stations would be placed. We negotiated the figure to \$3000 (thanks to Andy Van Treese) and relocated one of the stations to a better location.

The first round of letters to homeowners went out in January. The second round went out in early March. There are 21 total parcels in the project; there may be a need for one additional easement (yet to be determined) which would bring the count to 22.

If you received a letter, the city wants to install an individual grinder pump on your property. They will need to connect to your home's breaker box to provide power to your grinder. They will offer you a choice between accepting some money for the use of your land (and you would be responsible for future repairs of the grinder pump), or not accepting the money and the city would be responsible for any future repairs.

I'd caution anyone against agreeing to be responsible for future maintenance of their grinder, this is sure to be a major expense.

Victoria Burch and Steve Knies from Beam, Longest & Neff (the engineering company) are the Right-of-Way Buyers. Their job is to get you to sign the contract at the least expense to the City. Keep in mind that everything is negotiable. Residents have had great success getting the city to agree to relocate the pump at a better location on their property. Some residents have had concerns about taxing their electrical systems and are trying to negotiate electrical upgrades. Other residents have asked for more money than was offered AND an agreement from the City to maintain the equipment.

### Lake Rules Revision

The ILIA Lake, Beach and Water Safety Regulations have been amended to add, "The spoils area is off limits for recreational activities and access requires board approval."

This change is for safety reasons. Appropriate signage will be installed at the spoils area.

# Blast From The Past

The first Indian Lake Civic Committee met May 23, 1962 at the home of Lois Armstrong, who served as temporary chairman and was later elected permanent chairman. Seven other women attended. A treasurer was not elected as the board was asked for \$25.00, and small projects such as bake sales and recipe sales would help pay for incidentals.

This March 1965 revised constitution of the Civic Committee formalized the purpose of the organization and fine-tuned the rules for membership, officers and voting. It set a schedule for regular meetings and suggested four standing committees.

#### REVISED CONSTITUTION Indian Lake Women's Civic Committee

#### ARTICLE I Name

The name of this organization shall be the Indian Lake Women's Civic Committee.

#### ANTICLE II Objects

The purpose of this organization shall be:

1. To strengthen and enrich the community and neighbor relationship of the members of the Indian Lake Improvement Association.

2. To originate and implement Committee activity, Association action and individual programs which will stimulate community

awareness, closer contacts, and cooperation between neighbors.

3. To acknowledge that the strength of America today lies in its family units. That it is the particular duty of the women of this Committee to provide the atmosphere and facilities for the Indian Lake community which will attract and hold families who will, in turn, enrich, materially and socially, the homes and lives of other members.

#### ARTICLE III Membership

Section 1. The membership of the Women's Committee shall be

limited to twelve (12) members.

Section 2. The members shall serve three year terms

Section 3. Members shall automatically be retired following each three year term.

Section 4. Retirod members shall be eligible for re-election following a one year period by vote of the Committee. Section 5. Members shall be elected to the Committee by a vote

of ten of the twelve active members. Section 6. An unlimited number of non-committee member workers

may be activated by the Committee to work on committees, special projects and/or activities of the Committee. These non-member workers shall be considered potential recruits for Committee memberships.

Section 7. Any person replacing a retiring member would fill out the rest of that persons term. If the remaining term was less than six months long, it would remain vacant until the beginning of the next term.

#### ARTICLE IV Officers

The officers of this organization shall be President, First Vice-President, Second Vice-President and Secretary-Treasurer, Section 1. An officer may not hold the same office for two years in succession.

Section 2. The President shall be elected each year from among Committee members who have served a minimum of one year.

The duties of the President shall be: 1) to preside at

all meetings of the Committee; 2) to assume the responsibility

### The Real Storm Water Utility Story

When the Marion County Storm Water Utility was created around 2001, Lawrence originally wanted to run its own program. What happened instead is that Lawrence agreed to join the Marion County program, with the understanding that Lawrence would get its fair share of storm water projects. That's not how things worked out. Depending on how you do your accounting, Lawrence has seen few storm water projects since.

In 2014, Marion County decided to increase storm water fees. The current fee is \$27 a year per homeowner (you pay this as part of your property tax bill). The amount of the increase varies from homeowner to homeowner, and is based on a formula using the impervious area of each property. I calculated my new fee to be \$66, a 144% increase.

When Mayor Jessup caught wind of this, he was rightly upset at having to pay yet more money into a fund providing no benefit to Lawrence. The Mayor decided it was time to separate Lawrence from the Marion County Utility. Two members of the Lawrence Common Council introduced an ordinance to that effect.

The ordinance also included a bond issue to borrow 6.5 million dollars. About half of the money would be paid to Marion County as a separation fee, the other half would be used to fund Lawrence's storm water program. This was a pill that was too hard to swallow by the majority of the Council. The opposing faction, headed by councilors Collier and Parnell, instead favored restructuring the deal with Marion County by interlocal agreement, to assure that Lawrence would get its fair share of projects, and be able to recoup some of the approximately 9 million dollars that the citizens of Lawrence paid into the fund. That ordinance was passed by the Council in January.

Only time will tell if the restructuring will work as hoped.

As an additional note, Lawrence has the ability to set its own storm water tax rates. It could opt to keep the current rate, increase rates using the new Marion County formula, or none of the above. Until it's clear that Lawrence is actually able to benefit from its fees under the interlocal agreement, the prudent approach would be to delay a rate increase.

# The Finer Points of Recycling

The Indian Lake Community has one of the highest participation rates in curbside recycling in Lawrence. Indian Lake residents may be interested in knowing some of the finer points of modern recycling.

Recycling technology continues to advance. We've recently moved from hand-dumped bins to bins dumped by mechanical arms. More types of materials can now be recycled, and the material separation requirements are getting more lenient.

### Tips for Recycling in the Modern Age

- Keep plastic caps and closures on plastic bottles and containers at the point of recycling. Bottles are ground into flake before being vigorously washed in the recycling process. The washed cap material is then separated from the bottle material during a water bath float/sink process. Note: metal caps should be removed from bottles.
- Keep recycling and trash bins at least four feet apart at the curb. If they're any closer, the truck operator will have to leave the vehicle to separate them so the mechanical arms can grab them.

· Recycle the following materials:

#1 through #7 plastics, including plastic bags

Glass bottles and jars

Empty aluminum, metal, tin and steel cans

Newspapers and inserts

Magazines, phonebooks, soft cover books

Cardboard/Cereal box type packaging, brown paper bags

Office and school papers
