

Across the Fence

President's Message

ANNUAL MEETING

Our 2023 annual neighborhood meeting was held on Monday, January 16 at 7 PM at the Jenn Park Pavilion. The meeting was well attended and allowed us to elect board members, approve an annual budget, and discuss neighborhood topics.

The board proposed no increase in the 2023 budget and it was approved by the membership.

One neighborhood topic that was discussed was the amending of the covenants regarding ownership rights of Block F, Block K, and Playgrounds A and B. Another was the creation of an Architectural Control Committee to create guidelines for structures requiring board approval by the covenants. These topics will be the subject of continuing discussion in 2023.

The board would like to welcome new board members Tom Crouch and Kate Dydo and returning member Phil Marble. The board would also like to thank Kyle Hurd and Andy Van Treese for their dedicated service to the board and the Indian Lake community.

INDIAN LAKE COVENANTS, ARCHITECTURAL **CONTROL, AND THE BOARD**

I'd like to use this President's Message to discuss the powers and limitations of the board when it comes to architectural control. The board is often called upon to take action related to new or existing structures and must act according to our governing documents.

At Indian Lake, the covenants dictate the most important rules for the Association. The members themselves are the Legislative branch of Indian Lake government. They have full power to approve or disapprove changes to the covenants. The board is the Executive branch. The board is granted powers by the covenants and cannot act beyond them.

Board is required to approve/disapprove plans at the time of construction

Prior to construction, members are required to submit plans to the board and the board is required to approve or disapprove them within thirty days. If approved, that approval is perpetual, and not subject to later revocation. For example, if a member received approval to build a detached garage from the board, a later board couldn't come back and say that the garage needed to be moved or modified.

Note that approval by the Board of a correctly filed application shall not be deemed to be an approval by local governing authorities (i.e., the city of Indianapolis) nor a waiver of the applicant's obligation to obtain any required approvals from any such authorities or to otherwise comply with applicable local ordinances.

Structures prohibited by the covenants

A second type of situation involves architectural control elements that are prohibited by the covenants. These include structures that are not private residence buildings, private garages, or garden houses. Examples can be found in Article VI, Section 4 of the covenants. These are subject to removal at any time, regardless of how long ago they were erected.

When the board is not granted authority by the covenants

A third type of situation is for architectural control elements that fall outside the scope of the covenants. Examples include mailboxes, trailer and RV parking in driveways, holiday yard displays, and the general upkeep of members' homes. Some of these are subject to Lawrence or Marion County ordinances, but not the covenants. The board is often asked to intervene in complaints involving some of these. If a municipal ordinance is involved, the board may ask Lawrence or Marion County for enforcement. Residents may do the same. Where no covenant or ordinance is involved. the board has limited enforcement authority and must often rely on goodwill.


